If this investment is accepted and subsequently forms part of your pension fund we may require the value of the investment to be formally valued at specific points in the future, such as on the sale to a connected party or when you wish to take benefits for example. This requirement depends on the way in which the investment is structured and the underlying assets. This is a legislative requirement and is not discretional. The valuation must be done by a suitable qualified professional party, unconnected to either you or the company involved.
